

IZKUŠNJE

Matej Golob Matzele je član uprave (zadolžen za področje komerciale) Abanke od decembra 2015. Ima več kot dvajset let izkušenj v finančnem sektorju, od tega več kot dvanajst let v bančništvu. V zadnjih petnajstih letih je bil na različnih vodstvenih položajih na področjih upravljanja premoženja, investicijskega bančništva in prestrukturiranja. Abanki se je pridružil septembra 2012 kot vodja področja za poslovanje s pravnimi osebami.

Pred zaposlitvijo v Abanki je bil izvršni direktor in član upravnega odbora PDP d.d., družbe za prestrukturiranje v državni lasti. Med letoma 2006 in 2009 je bil generalni direktor investicijske družbe Poteza naložbe. Med letoma 2004 in 2006 je v Kapitalski družbi, družbi za upravljanje premoženja v državni lasti, opravljal funkcijo direktorja Sektorja za upravljanje premoženja. Prav tako je bil upravljaec Zaprtega vzajemnega pokojninskega sklada za javne uslužbenke. Med letoma 1997 in 2004 je bil zaposlen v banki Bank Austria Creditanstalt d.d. v Ljubljani, kjer ga je službena pot vodila od položaja borznega posrednika do vodje oddelka vrednostnih papirjev, vodje divizije globalnih storitev z vrednostnimi papirji, vodje divizije upravljanja premoženja in trgovanja z vrednostnimi papirji ter prokurista. Poslovno pot je leta 1996 začel kot borzni posrednik v borznoposredniški družbi Bema. Deloval je tudi kot predsednik ali član nadzornih svetov različnih slovenskih in regionalnih družb.

Matej Golob Matzele, born in 1972, has been a Member of the Management Board (as a Chief Marketing Officer) of Abanka since December 2015. He had held different management positions in the fields of asset management, investment banking and restructuring over the past 15 years.

He joined Abanka in September 2012 and was responsible to manage the Corporate Banking Division.

Prior to joining Abanka, he was the CEO and a member of the Board of Directors in PDP d.d., a state-owned restructuring firm. Previously, from 2006 to 2009 he was a Managing Director of the investment company Poteza Investments. From 2004 to 2006 he worked at the Capital Fund, a state-owned asset management company as a Director of Investments and Asset Management Department. He also managed the Closed Mutual Pension Fund for Civil Servants. Between 1997 and 2004 he worked at Bank Austria Creditanstalt d.d. in Ljubljana, where he went from stockbroker to head of the securities department, head of the global securities services division, head of the asset management and securities trading division and procurator. He began his business career in 1996 as a broker for the stockbroking company Bema. In his career, he acted also as a chairman or a member of Supervisory Boards in different Slovene and regional companies.
