



# Status on development of Whole Grain Partnership in Bosnia and Herzegovina






- -BIH Ministry of Civil Affairs state level institution with competencies related to health sector in BIH, a partner in WholEUGrain Consortium;
- Accession of two key partners (entity Public Health Institutes of the Federation BH and the Republic of Srpska) to the WholEUGrain Project has been initiated recently;
- Format/level of WG Partnership establishment in BIH will be decided in the near future taking into account competencies in the health sector in BIH...

### Political ground for initiation of Whole Grain Partnership in Federation of BH

- Several policy and strategic documents that express government's commitment to work on improvement of nutrition and overall health of the population of Federation of Bosnia and Herzegovina served as basis for Whole Grain Partnership initiation.
- Of particular importance for initiation of Whole Grain Partnership is Health sector's Action Plan for Prevention and Control of Chronic Non Communicable diseases of Federation of Bosnia and Herzegovina 2019-2025, brought by the Ministry of Health of Federation of BH in 2019.

### Political ground for initiation of Whole Grain Partnership in Federation of BH

**Action Plan for NCD Prevention** and related programs include activities such as:

- Creation and conduction of campaigns related to nutrition as a risk factor for development of non-communicable diseases and promotion of healthy nutrition including promotion of consumption of wholegrains
- Food reformulation (reduction of salt, trans fats in bread and bakery products)
- Improvement of legislation related to information of consumer with the aim to raise awareness on content and quality of food products
- Conduction of surveys on dietary habits of different population groups
- Recommendations for consumption of wholegrain products in all guidelines for different population groups and guidelines for different settings

## What has been achieved so far in establishment of Whole Grain Partnership in Federation Whole User of BH

- Initial mapping of stakeholders has been done and it included one federal and 10 cantonal public health institutes and major bread producers from 10 cantons
- Stakeholders were invited at Stakeholders event where WholeEUGrain Project and basic principles of Wholegrain Partnership have been presented
- Federal Public Health Institute has been identified as potential driving force in WGP establishment and its involvement in WholEUGgrain project as affiliated entity proposed
- List of stakeholders has been extended to include relevant governmental and non governmental institutions and organizations and invitation for participation in the First Whole Grain Summer School has been sent

### Next steps in organization of Whole Grain Whole UGrain Partnership in Federation of BH

- Decision and official nomination of government's institution that will lead the process
- Contacting relevant institutions and organizations for nomination of their representatives
- Establishment of intersectoral working group/task consisted of representatives of principal partner institutions and organizations responsible for coordination of process
- Preparation of action plan and determination of responsibilities
- Capacity building of involved stakeholders for conduction of task (Summer schools)

### Major challenges in organization of Whole Whole Grain Partnership in Federation of BH

- Complicated administrative organization of the entity consisted of 10 cantons functioning independently that hardens formation of WGP task force, determination of responsibilities and implementation of whole process
- Willingness of producers to engage in reformulation and development of new products
- Insufficient capacity of different stakeholders for conduction of assigned tasks
- Lack of financial resources for implementation
- Lack of data (on WG intake and supply, consumer knowledge, buying behavior etc.)






