
DIRECTIVE (EU) 2023/2668 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 22 November 2023 amending Directive 2009/148/EC on the protection of workers from the risks related to exposure to asbestos at work :

Recital:

(29) It is important that the Commission, in cooperation with the ACSH, develop and issue guidelines no later than two years from the date of entry into force of this Directive, in order to facilitate the implementation of this Directive. Those guidelines should, where appropriate, include sector-specific solutions.

- Initial stakeholder engagement to identify existing guidance (July-September 2024)
- Guidance development workshops (30th October 4th December 2024)
- Consultation on the draft guidance (early 2025)
- Pilots (February March 2025)
