1. What are personal data?

Personal data refers to any information related to a specific individual, regardless of the format in which it is presented. This includes data that can identify a person. Examples of personal data include, but are not limited to, name, surname, address, personal identification number, telephone number, etc.

2. How and for how long will we store your personal data?

Personal data obtained and stored with your consent will be kept in an electronic database of personal information. They will be stored for as long as necessary to achieve the purpose for which the data was collected or until the withdrawal of consent. All databases are adequately protected, and data is stored in accordance with applicable data protection laws.

3. Processing and use of your personal data

The processing of personal data will be carried out in accordance with the General Data Protection Regulation (GDPR) and the Personal Data Protection Act (ZVOP-2). Personal data may only be collected, managed, and processed based on explicit written or digital consent, if data collection is necessary for the conclusion of a contract with you, or if there is a legal basis for collecting personal data.

4. Purpose of processing personal data

Personal data for which we require your specific written consent is collected, used, and processed only within the scope of the purpose for which the data was collected. We commit not to disclose your personal data to third parties without your explicit written consent.

5. Your rights in the field of personal data protection

In accordance with the General Data Protection Regulation (GDPR), you have the right to various protections related to personal data, including the right to delete and correct incorrect data, the

right to limit processing, the right to data portability, the right to object, the right to access personal data, and the right to file a complaint.

You can exercise all rights by submitting a written request, signed and addressed to the Chamber of Commerce and Industry of Slovenia - Chamber of Construction and Building Materials Industry (GZS ZGIGM), Dimičeva Street 13, 1504 Ljubljana, or digitally signed via email: zgigm@gzs.si.

6. Revocation of consent for the processing of personal data

You can revoke your consent for the processing of personal data at any time. The revocation of consent does not affect the lawfulness of the processing of personal data before the revocation. You can revoke your consent by submitting a written and signed request addressed to the Chamber of Commerce and Industry of Slovenia - Chamber of Construction and Building Materials Industry (GZS ZGIGM), Dimičeva Street 13, 1504 Ljubljana, or digitally signed via email: zgigm@gzs.si.

7. Right to delete and correct incorrect personal data

You have the right to request the correction or deletion of incorrect personal data. In the case of correction, supplementation, or deletion of personal data, we will inform you as soon as the changes are made.

8. Right to limit the processing of personal data

You have the right to request the limitation of the processing of your personal data in case of identified inaccuracies, invalidity, or expiration of the reason for which the data was collected.

9. Right to transfer your data

You have the right to request your personal data processed in connection with you. You also have the right to request that your personal data be transferred to a third party.

10. Right to object

In addition to the right to revoke consent, you have the right to request the cessation of using your data for information or direct marketing without your specific consent. It is the duty of the Chamber of Commerce and Industry of Slovenia and our partners to immediately cease such activities upon your request.

11. Right to access personal data about you

You have the right to obtain information about any personal data related to you, including the purpose of processing, the type of data relating to you, users of your personal data, estimated storage period, and the source of personal data.

12. Violations regarding the protection of personal data

In the event of a detected breach of the protection of personal data, we will inform you immediately. In the event of a breach or intrusion into personal data, we will immediately, but no later than 72 hours after notification of the breach of the protection of your personal data, inform the appropriate institution.

13. Right to file a complaint

If you believe that your personal data is not processed in accordance with the applicable data protection laws, you have the right to file a complaint with the Information Commissioner, Dunajska Street 22, 1000 Ljubljana, or by email: gp.ip@ip-rs.si.

14. Important notice regarding the processing of your personal data

We handle your data in accordance with the current Personal Data Protection Act and the General Data Protection Regulation (GDPR). We reserve the right to change and update the Privacy Policy.
