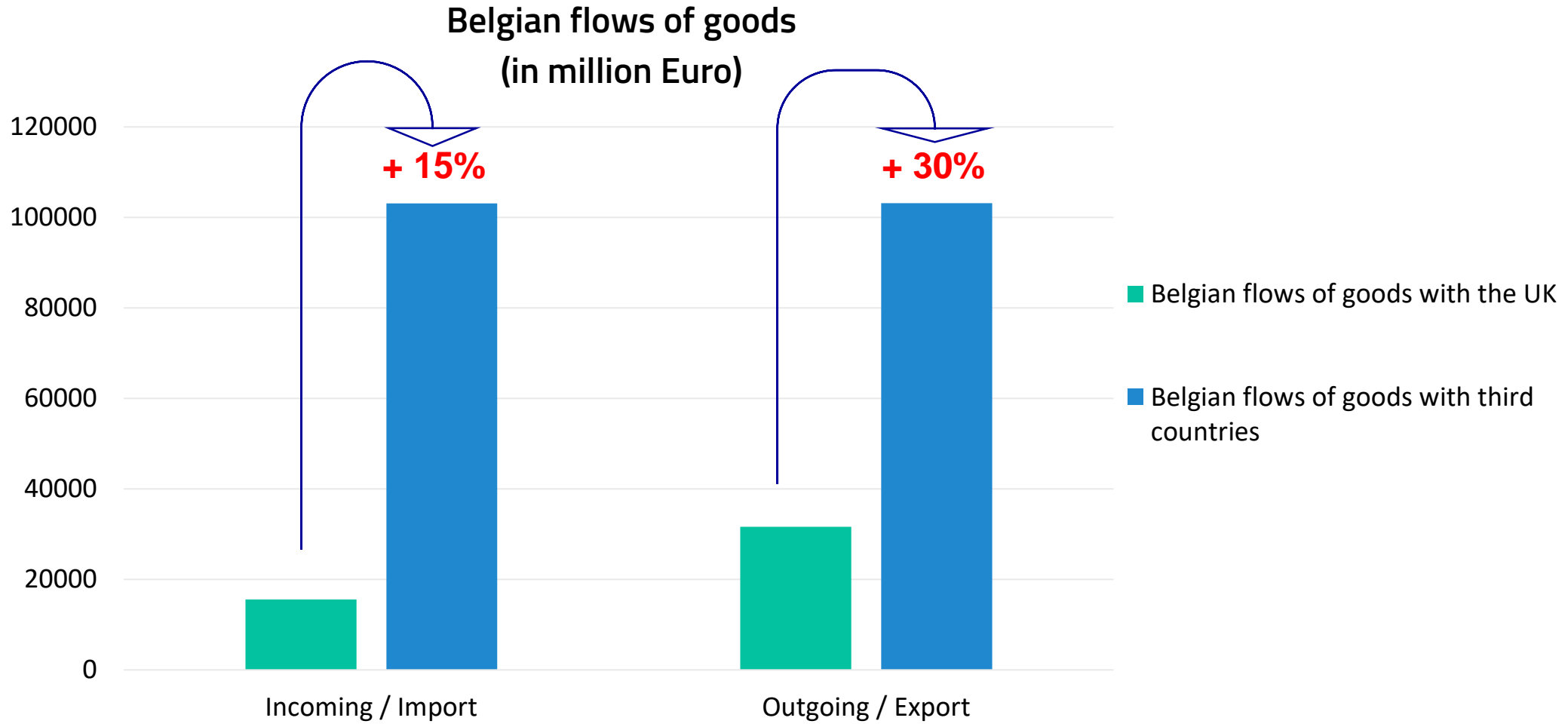

Notable growth of import and export (UK)



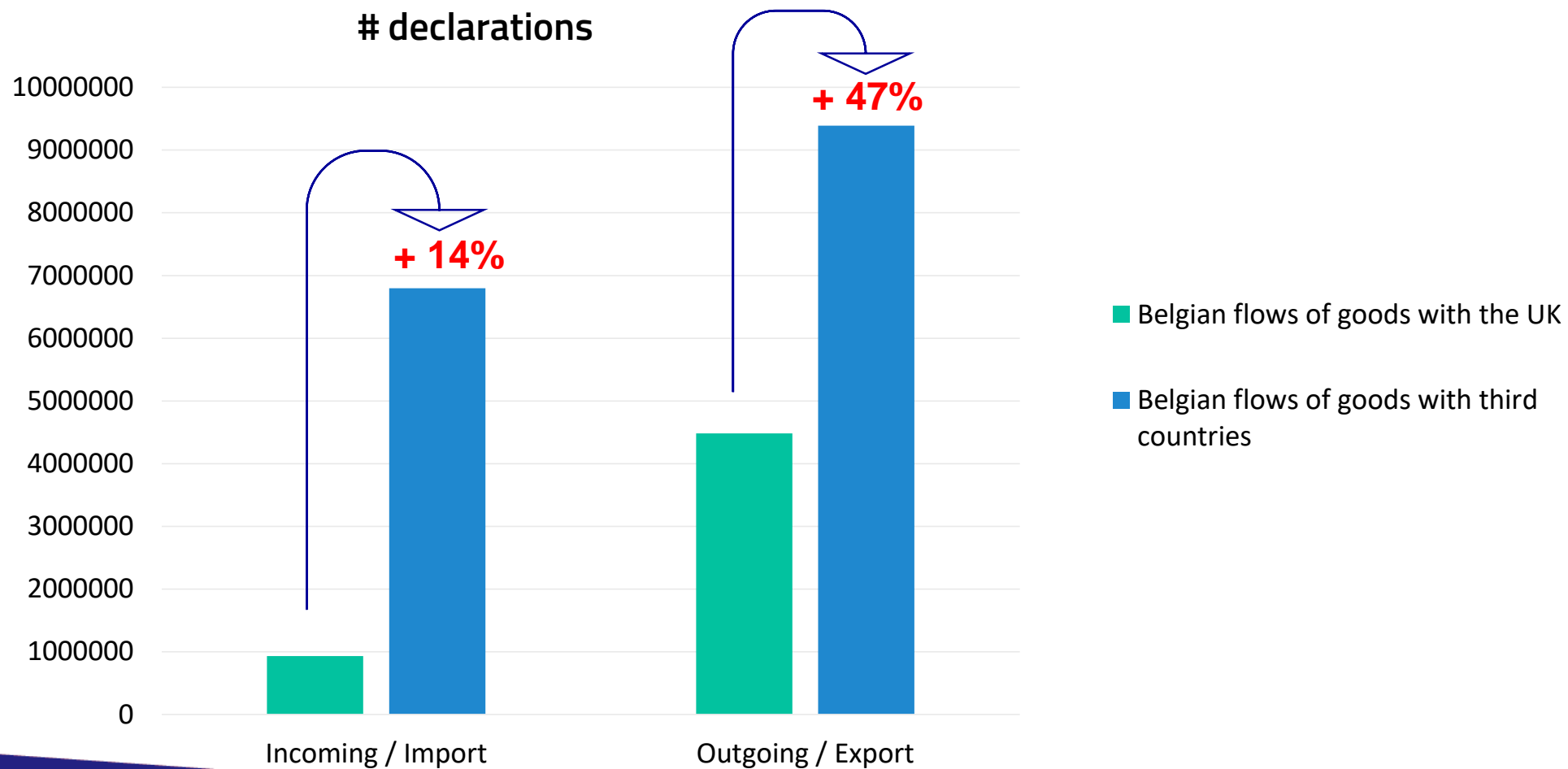
