We hereby agree, that we will abide the Rules for the issue of Certificates of Origin and other instructions in force at the time of Issue of the Certificate or certification of other documents. We also agree, that we will at all times keep the issuing body and its officials indemnified against any claims or demands whatsoever which may at any time be made against them by reason of any fault, defect, omission or inaccuracy in the content of the Certificates or other documents, or in the manner of their issues, unless otherwise provided by law.

In the event of request, which stems from a legitimate enquiry on the basis of statutory authority (e.g. police, financial control or any other control based on a decision of the administrative body or court), we hereby permit the issuing body to allow direct access to commercial information, which may be the subject of such an inquiry.
