**Territorial application:** Territory of Lithuania

**Field of application:** Istanbul Convention and its Annexes **A** (*Reservation: ATA Carnets shall not be used in postal traffic*); **B1, B2, B3** (*Reservation: in respect of Article 5, paragraph 1, a Customs document and the provision of security shall be required for temporary admission of containers, pallets and packings*), **B5** (*Reservation: in respect of Article 4, the standard procedures of temporary admission shall be carried out in connection with temporary admission of scientific equipment and pedagogic material*), **B6, B9, C** (*Reservation: in respect of Article 6, a Customs document and security may be required for temporary admission of motor vehicles for commercial use and means of transport for private use*).

**Other applications:** ATA Carnets **are not** accepted for postal traffic

ATA Carnets **are** accepted for transit.

ATA Carnets **are not** accepted for unaccompanied goods.

## Languages in which Carnets should be completed

Lithuanian and English. The Customs may require a translation when the ATA Carnets are completed in any other language.

**Replacement carnet** Yes, in accordance with Article 716a of EU Customs Code

**Regularization fee requested by Customs** No

**Customs offices:** Lithuanian Customs offices will process ATA Carnets during the following opening hours:

- (1) 24 hours a day for Customs offices located on border crossing points
- (2) From 8 a.m. till 5 p.m. for inland Customs offices

## **Special observations**

### **Instructions regarding the operation of the ATA Carnet System in Lithuania**

In accordance with the Republic of Lithuanian Customs Code rules on the implementation of the ATA Carnet System in Lithuania are the following:

1. The movement of goods from Customs offices located on the border of the Republic of Lithuania to internal Customs offices, in whose area of responsibility the goods will be used will be regularized by using ATA Carnet blue transit sheets.
2. Under the Republic of Lithuania Customs rules, blue transit sheets of ATA Carnets are used by Lithuanian Customs offices:
  - a) for internal transit from Customs offices located on the border of the Republic of Lithuania to internal Customs offices only for holders who have a legal entity;
  - b) for transit.
3. The following 15 internal Customs offices are authorized to accept ATA Carnets:  
Alytus, Kaunas, Klaipeda, Marijampole, Panevezys, Siauliai, Taurage, Telsiai, Mazeikiai, Utena, Vilnius and airports (Vilnius, Kaunas, Palanga, Siauliai).

At the location of exhibitions or other events, additional internal Customs offices will be able to operate subject to information provided by the organisers.

4. ATA Carnet holders or representatives of ATA Carnet holders, named in boxes A and B of the front cover of the ATA Carnet, or third persons with power of attorney (established in Lithuanian or English), are entitled to present goods.
5. The establishment of the general list of the ATA Carnets by electronic means will speed up the work with the ATA Carnets.
