## (2) Special conditions

- (a) The goods cited in paragraph (1) (j) above can be transported by the person concerned or imported separately, as unaccompanied goods. Any person claiming exemption from duty on articles imported separately as unaccompanied goods shall, at the time of entry into Japan, submit to the Customs a declaration stating the description, quantity, date and place of importation and place of shipment of such articles and obtain a Customs certificate stating that this declaration has been made. The person in question shall import the said articles within 6 months after his entry into Japan, unless the Director General of Customs recognizes that special unavoidable circumstances prevent this.
- (3) Carnets **are also accepted** for split consignments.

## Languages in which Carnets should be completed

English or Japanese

The Customs may require a translation if the Carnet is completed in any other language.

Special observations	Sporting equipment for international sport events can be covered under ATA Carnets as Professional Equipment or Exhibitions & Fairs. Japanese Customs do not accept a Replacement Carnet so the goods imported under a Carnet are not able to be retained in Japan over the validity of the ATA Carnet. Using a Carnet does not eliminate the usual requirements for restricted goods or licensing controls, and consumable and disposal goods should not be imported under a Carnet even if they are to be used for the international sport event.
