Note to national guaranteeing associations members of the ICC WCF ATA Carnet international guaranteeing chain

Implementation of the ATA Carnet System in Peru as of 30 April 2024

- National guaranteeing associations are informed that, as of 30 April 2024, the Lima Chamber of Commerce will become the 79th operational guaranteeing association member of the ICC WCF ATA Carnet international guaranteeing chain.
- 2. ATA Carnets will be accepted by the Peruvian Customs under the WCO Convention on Temporary Admission (Istanbul Convention, 26 June 1990) and its Annexes A (temporary admission documents) and B1 (concerning goods for display or use at exhibitions, fairs, meetings or similar events) and B2 (concerning professional equipment).
- 3. ATA Carnets are accepted for postal traffic.
- 4. ATA Carnets are accepted for transit
- 5. ATA Carnets are accepted for goods transported as cargos as well as hand-carried goods.
- 6. ATA Carnets issued by Contracting Parties to either the ATA Convention or the Istanbul Convention, or to both Conventions, are accepted.
- 7. Importation in split consignments is accepted.
- 8. Replacement Carnets are accepted in accordance with Article 14, Annex A of the Istanbul Convention.
- 9. All Customs offices are authorised to handle ATA Carnet procedure.
- 10. The responsibility of the national guaranteeing associations shall not exceed the amount of import duties and taxes payable by more than 10%, as specified in Article 8 (2) of Annex A to the Istanbul Convention. Penalty amount that goes beyond the responsibility of the national guaranteeing associations shall be directly imposed on the holders.

- 11. In case of wrong declarations as to the value of the goods, the ATA Carnet shall be rejected at the time of import.
- 12. In case a claim is regularised by evidence other than the re-exportation counterfoil completed and stamped by the Peruvian Customs authority, Peru Customs reserves the right to charge a regularisation fee. The amount is to be confirmed but shall be consistent with the provision of Article 10 and 11 of the Annex A, Istanbul Convention.
- 13. ATA Carnets may be completed in English or Spanish. The Customs may require a translation when the ATA Carnets are completed in any other language.
- 14. The Lima Chamber of Commerce is authorized to receive and remit all sums related to the operation of the ATA System.
- 15. The Lima Chamber of Commerce has duly signed and returned to the WATAC Secretariat a copy of the Interchamber Protocol on the organization of a system of international customs deposits in respect of ATA Carnets (Document 550/212 Rev. 2) and the Statement on the ATA System (Document 550/521 Rev. 1).
- 16. The Lima Chamber of Commerce has also provided the WATAC Secretariat with the guarantee act required by the ICC WCF.
- 17. All sums due to the Lima Chamber of Commerce in connection with the operation of the ATA System should be remitted to the following bank:
