announce their intent to **establish the Alliance for Advancement of VET in the Metal and Electro Industry** after the end of the skillME project.

## The aim of the Alliance is to:

- Disseminate and exploit created project results,
- Create an action plan for the accreditation of created curriculums in all four project participating countries with the aim to integrate them into national education systems,
- Strengthen the cooperation and exchange of information on skill gaps and future labour needs among key actors at national and transnational level,
- Create new projects for VET (vocational education and training) needs of the electro and metal industry and find the necessary means for funding,
- Attract new members from the project participating countries and other EU countries.

## The Alliance shall sustain the results of the project skillME by:

- Focused distribution of the dissemination package (the four curricula, research findings etc.) to various stakeholders,
- Marketing of curriculums through training catalogues of representative project partners,
- Integrating the curriculums into national catalogues of "open learning" courses for stimulating national VET providers to include the curriculums into their education portfolio,





- VET project partners including the curriculums into their courses portfolio offered to trainees and companies, thus sustaining the created curriculums in the long term,
- Integrating all 4 curriculums into educational programmes on national level in project countries after the completion of the accreditation process.

The Alliance shall be hosted by CCIS at its premises. The CCIS shall coordinate the Alliance's activities and shall ensure its promotion through the Alliance website, which shall be based upon the current skillME project website.
