Market Drivers

Opportunities for EU-India collaboration in biotechnology are multi-fold:

- The Indian biotechnology market is the third largest in Asia, after China and Australia
- The Indian biotech industry grew threefold in just five years to report revenues of €2.15 billion in 2009-10 and is expected to touch €6.44 billion by 2015.
- There is a strong biotechnology regulatory system in India that is encouraging development of Intellectual Property applicable to all subsectors.
- India is among the world's leading vaccine producers with more than half a dozen of the world's top Vaccine manufacturer's present.
- Clinical trials in India is booming and there is about 30–50% cost advantage over a similar trial in the US or Europe.
- The Bio-Pharma industry offers a wide scope for business and technology transfer. By 2020, the

market is projected to be worth over €150 billion, with a focus shifting from conventional drugs to bio-pharma products, the launch of bio-similars and a new generation of bio-therapeutics.

- The Bio-agriculture sector is vital for India to meet the increasing food demands of its growing population, with limited arable land and depleting water resources.
- Bio-informatics and Bio-services, with a well developed R&D capability, are ideal for outsourcing.
