The Indian advantage

Global new investment in renewables rose 17% to a record €203 billion¹ in 2011, as per 2012 REN21 Global Status Report on Renewables. With a growth of 62%, India displayed the fastest expansion in investment of any large renewables market in the world. In 2011, India attracted €9.5 billion² investment one of the top 5 new capacity investment in the world. In the wind sector, India was the third largest market in 2011 for the second year running, adding about 3 GW for a total of approximately 16.1 GW of capacity, maintaining its fifth place ranking for total installed capacity. With the National Solar mission policy boost, of achieving 20 GW by 2020, solar investments in India are on the rise, from a mere 10 MW in 2010, the current installed capacity crosses just above 1 GW.
